**ORDER FOR SURRENDER AND  
CONSENT TO THE SAME**

Arthur R. Sakakihara-Chavarria, P.A. ("Respondent") elects to permanently waive any right to a hearing and appeal with respect to this Order for Surrender; admits the jurisdiction of the Arizona Regulatory Board of Physician Assistant ("Board"); and consents to the entry of this Order by the Board.

FINDINGS OF FACT

1. The Board is the duly constituted authority for the regulation and control of the practice of allopathic medicine in the State of Arizona.
2. Respondent is the holder of license number 4404 for the performance of health care tasks in the State of Arizona.
3. The Board initiated case number PA-13-0037A, for Driving Under the Influence in South Dakota.
4. Respondent was ordered to undergo an evaluation for alcohol use disorder by a Board approved addictionologist located in Arizona. Respondent reported that he was unable and unwilling to do so.
5. Respondent thereby admits to a violation of A.R.S §32-2501(18)(k)(Violation of a formal order, probation, or stipulation issued by the Board).

CONCLUSIONS OF LAW

1. The Board possesses jurisdiction over the subject matter hereof and over Respondent.

3 of action related thereto or arising from said Order.

4 4. The Order is not effective until approved by the Board and signed by its  
5 Executive Director.

6 5. All admissions made by Respondent are solely for final disposition of this  
7 matter and any subsequent related administrative proceedings or civil litigation  
8 involving the Board and Respondent. Therefore, said admissions by Respondent are  
9 not intended or made for any other use, such as in the context of another state or  
10 federal government regulatory agency proceeding, civil or criminal court proceeding,  
11 in the State of Arizona or any other state or federal court.

12 6. Upon signing this agreement, and returning this document (or a copy thereof)  
13 to the Board's Executive Director, Respondent may not revoke the consent to the entry  
14 of the Order. Respondent may not make any modifications to the document. Any  
15 modifications to this original document are ineffective and void unless mutually  
16 approved by the parties.

17 7. This Order is a public record that will be publicly disseminated as a formal  
18 disciplinary action of the Board and will be reported to the National Practitioner's Data  
19 Bank and on the Board's web site as a disciplinary action.

20 8. If any part of the Order is later declared void or otherwise unenforceable, the  
21 remainder of the Order in its entirety shall remain in force and effect.

22 9. If the Board does not adopt this Order, Respondent will not assert as a  
23 defense that the Board's consideration of the Order constitutes bias, prejudice,  
24 prejudgment or other similar defense.
